MODERATOR, Two-Year Term:

[Two-year Term to end 2026; served two years as Vice-Moderator, first year of nomination]

Jodee Lord, Oakwood Heights Community Church, Staten Island, New York

Jodee Lord is a member of Oakwood Heights Community Church on Staten Island, N.Y. She is actively involved in life at Oakwood and its community, serving on the Board of Deacons, Church Council, Pastoral Search Committees, Board of Trustees, Church Choir, and a food pantry volunteer. Jodee serves as 1st Vice President of S.I. Council of Churches and as Co-Chair of Congregational Support and Outreach. She has a deep dedication to the NACCC.
