The Foundation was pleased to offer the Executive Certificate in Religious Fundraising (ECRF) at a highly discounted rate. 16 people, representing churches, the Congregational Library and Archives, and the NACCC, participated in the eight-week course through the Lake Institute on Faith & Giving, part of the Indiana University Lilly Family School of Philanthropy.

Your support and generosity allowed the Foundation, serving alongside the Board of Directors and Leadership Council in FY2024, to further the work of the Ministry Councils, *The Congregationalist*, the Center for Congregational Leadership, and other worthy efforts. The Foundation distributed \$95,000 to the NACCC as part of the collaborative budget process. Likewise, we are pleased to partner with the NACCC in the Congregational Investment Trust (CIT). NACCC, Foundation, and member church investments combined in the CIT strengthen the financial position for all of us! As intended, gifts from donors were allocated to the NACCC at levels comparable to previous years.

On a Foundation personal note: We welcomed Rebekah Barsch to the board. A *Cradle Congregationalist* with an extensive background in finance, Rebekah is an insightful addition to the Board. We recognize Ashley Cleere for her dedication and leadership to the board, as board member, board, president, and Executive Director. We wish her all the best in her new ministry.
